**THE PARTIES AGREE TO THE FOLLOWING:**

1. The Transmission Customer is responsible for fulfilling all of its obligations and requirements under the Transmission Provider’s OATT.
2. The Cooperative and the Transmission Provider are authorized to use the Transmission Customer as the sole point of contact with the CSP concerning the CSP’s provision of Electricity Supply Service.
3. The CSP authorizes the Cooperative to bill the Transmission Customer directly for all transmission-related charges attributable to the CSP. The Transmission Customer agrees to pay the Cooperative such charges on behalf of the CSP in accordance with the terms and conditions in the Agreement. The Transmission Customer will remain solely responsible for the payment of all charges under the applicable OATT.

4. The CSP and any properly designated Transmission Customer shall comply with all terms and conditions of the Agreement, including those pertaining to Transmission Customers and to payment and billing.
